### **Training Overview**

This 12 CE-hour, Advanced EMDR training opens the door to your next level of effectiveness when treating developmental trauma and attachment injuries. It provides a deeper understanding of the EMDR AIP model, the three-pronged approach of past, present, and future, and the application of clinical interweaves to optimize reprocessing effects. It takes you from identifying similar past experiences to the client's present-day situation to the client's adaptations to their formative experiences, which can be as disruptive as the original traumatic events. This deeper, more nuanced understanding of working with attachment trauma provides the EMDR therapist a conceptual map with multiple pathways, further developing your skills and increasing your confidence in navigating the journey towards healing.

#### Preparing for Your Training Experience

This online training consists of lecture, discussion, and review of client video segments, giving you ample opportunity to ask questions in this live, online format. #### **Overall Training Objectives**

**1.** To understand the four adult attachment styles through an AIP framework and identify the client's adaptations that correlate with their predominant attachment style.

2. To understand and identify how these adaptations inform the client's response to the demands of EMDR therapy, both in and out of reprocessing

**3.** Develop an AIP-informed case conceptualization of the client's current difficulties.

 Develop a treatment plan that target the memories that are at the root of these adaptations.

5. Identify more adaptive and flexible relationship skills for the client to successfully integrate into their current lives

**6.** Learn to apply Clinical Interweave Categories (CIC) to navigate moment to moment re-







processing demands to address developmental deficits and facilitate attachment repair
7. Develop greater ease in applying the three-pronged approach of past, present, and future to best meet the client's needs.

#### Eligibility

This training is for mental health professionals who have completed the EMDR Basic Training, are licensed for independent practice, or on a licensing track under supervision. It is recommended that you have at least six months of practice experience using EMDR with your clients in order to fully benefit from this course.
